1. **We believe the Bible is God breathed, inspired by the Holy Spirit and the absolute Word of God.** Deuteronomy 4:2, Psalm 19:7-9, Proverbs 30:5-6; 1 Corinthians 2:10; Galatians 1:6-10; II Timothy 3:16-17; II Peter 1:20-21.
